Call to Order

A. District Engineer

Mr. Fischer stated that he has a report from the resident at 11517 Oxcroft with a concern of what appears to be a portion of the pond bank. Mr. Woodcock will complete an inspection.

Mr. Fischer introduced Ms. Gaydos and asked that she address questions regarding the status of permits that are in both the District's and HOA's name. She explained that SWFWMD requires both the owner of the pond/well and the user of the water to be named on the permit.

A brief discussion was held regarding ownership of the well and the responsibility for maintenance. Ms. Gaydos offered to prepare a graphic of the wells, noting who owns each of them. She opined that the well pumps are old and whichever entity is going to maintain them should be budgeting to replace them soon. District Counsel will be provided with the information so he can opine regarding any liability questions.

The Board asked that Mr. Woodcock look at the ponds.

B. Water Way Inspection Report

Mr. Fischer stated that he met with both representatives to review the report and obtain an update on the status on the aquatic planting. He stated that the plan is to initiate the program as soon as the soil stays moist after a rain fall. They anticipate that it will be within the month.

There were no questions on the report.

C. Field Services Manager

A brief discussion was held regarding how the deficiencies noted during the landscape transition walk through were addressed. It was noted that payment was withheld. Overall satisfaction was expressed with the performance of the new contractor thus far.
